## Be Vigilant with Fruit Fly

Recent fruit fly detections are a stark reminder that we must be vigilant and do all we can to protect the citrus production areas in the Murray Valley.

With many visitors expected in the Sunraysia area during the Easter and school holiday period, mobile fruit fly roadblocks will be in place to check that visitors are not bringing in fruit or vegetables. Motorists found breaching restrictions can be fined up to \$5,500.

Local residents are urged to contribute to the awareness to visitors of the devastating consequences of a fruit fly outbreak in the region which has fruit export markets worth millions of dollars.

If visitors have inadvertently brought fruit into the area it can be placed in a sealed plastic bag and left in the sun for at least a week or placed in the freezer for two days to kill any fruit fly maggots. Local fruit drop from home trees should also be bagged and left in the sun. If an outbreak is suspected in a home orchard, it should be reported immediately to DPI Victoria.

## **Copper Spray Application**

To achieve the best result and returns from export and local markets, March to early April is the optimum time for citrus growers to apply copper based sprays.

The benefits of copper based sprays are;

- Pre and post harvest disease control
- Leaf disease (control of greasy spot) and rind blemish disease (control of Septoria spot

• Control of snails in trees

Fruit for export and local markets should have an early autumn application to enhance postharvest fungicide control on fruit.

Use good quality copper spray products as some inferior brands can lead to fruit marking and blemish. Spray copper and wetters at label recommended rates and make sure leaves and fruit are well covered. Extra sprays may be needed in wet weather conditions; spray mid-morning when fruit is warmed.

## Peru Expects to Increase its Citrus Exports by 10% Annually

The Citrus Growers Association of Peru (ProCitrus) reported that in recent years the country has been increasing its citrus exports to the major markets of the world such as the UK, Netherlands, USA, Canada and Russia. Since the tendency is to increase exports 10% per year on average, they expected to export 100,000 MT (metric tons) this year.

The association also reported that Peru has been working permanently hand in hand with the SENASA (Puruvian Agriculture Department) in the opening of new markets. In recent years they have accomplished entry into China and Mexico, and in the next years they expect to enter Japan, Korea, Brazil and the Middle East. Scientific tests required for the opening of the Japanese market have been conducted since 2008.
