#### **Qfly Update**

Two Qfly outbreaks, Boundary Bend and Boundary Bend West have fulfilled the requirements for reinstatement for the domestic market and are declared to have fruit fly freedom for the domestic market (one generation and 28 days or 12 weeks, whichever is longer) as of 1 May, 2013. Growers in these areas may be affected by adjacent quarantine areas

#### **Export of Citrus to Thailand Revised Requirements**

The Thailand Department of Agriculture (DOA) has revised conditions for citrus being imported from Australia. The revised requirements are as follow:

- Grower registration is for orchards or blocks, previously only orchards were permitted.
- If non-compliance on arrival in Thailand occurs three times (once for Fuller's rose weevil) from a registered orchard or block, DAFF will suspend registration from the orchard
- Once an orchard or block is suspended, consignments containing fruit from the suspended orchard or block (including certified consignments in transit) will not be permitted entry into Thailand.
- The registered orchard/block number must be on the phytosanitary certificate.

These conditions are to be met for citrus entering Thailand from 20 May, 2013.

The new protocols can be accessed from 30 April, 2013 from the MICoR website. In order to view the documents online you are required to be registered. To register please select 'register with Plan Exports'.

### SCG/MVCB/NSW DPI Technical Field Day

Sunraysia Citrus Growers Inc and Murray Valley Citrus Board will be hosting a 'Grower's Technical Field Day' on 26 June, 2013 at the NSW Department of Primary Industries Dareton Primary Industries Institute.

The event is expected to attract 100 - 200 citrus producers from the tri-state region eager to see and learn about the latest technology, machinery, and agricultural products available in the citrus industry.

This Technical Field Day will be free for all Murray Valley citrus producers to attend and will bring international and national citrus experts to Mildura.

There will be two keynote speakers; Joshua Kanonich, an Israeli citrus extension specialist, and Pat Barkley, the eminent Australian citrus pathologist. Joshua will speak on the Israeli approach to mandarin production, and Pat will address the threat that the citrus greening disease, Huanglongbing, poses for the Australian citrus industry.

#### Other topics will include

- crop regulation from a grower's perspective;
- potential in the East Asian market for Australian citrus;
- electricity cost savings associated with irrigation;
- the financial feasibility of on-farm electricity generation using solar energy.

MVCB staff will carry out free maturity testing for all Murray Valley growers and packing sheds.
